

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING

SWEEPSTAKES PERIOD: The Photo Shoot at ACS Sweepstakes (“Sweepstakes”) begins on July 20, 2019 at 5:00 p.m. Pacific Standard Time (“PST”) and ends on July 20, 2019 at 11:00 p.m. PST (the “Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, there is one (1) way to enter: **(1) Onsite:** Visit the Auto Club Speedway display booth, during the Dub Show Event held at the Auto Club Speedway and follow the directions provided to complete the entry form and submit to receive one (1) entry into the Sweepstakes. Entries generated by script, macro or other automated, or mechanical, means or by any means which subvert the entry process are void. Limit one (1) entry per person, per email address and per household. Entries received from any person or email address or household in excess of the limitation will be void. ELIGIBILITY: Sweepstakes is open to legal residents of the fifty (50) United States and the District of Columbia who are of the age of majority or older in the applicable jurisdiction. prize details are at Sponsor's sole discretion. Auto Club Speedway and the winner will mutually agree upon one location for the photo shoot. Auto Club Speedway has the right to cancel, and select date and time of photo shoot. The winner must provide their camera and production. The winner cannot use the photo for promotional or commercial purposes. The winner can only use the photo for personal purposes. The photo shoot is for still photography only. No video or moving vehicle. Auto Club Speedway has final approval authority on the photo shoot. The photo shoot must be family-friendly. The winner can only bring their personal vehicle and must show they have insurance and it is registered in their name. The photo shoot is for up to two hours. An Auto Club Speedway representative(s) will accompany the winner during the entire photo shoot.
