

OFFICIAL RULES FOR THE “Summer Speedway Giveaway”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

SWEEPSTAKES PERIOD: Summer Speedway (“Sweepstakes”) at Auto Club Speedway begins on June 21, 2019 at 7 a.m. Pacific Standard Time (“PST”) and ends on July 21, 2019 at 5 p.m. PST (the “Sweepstakes Period”).

HOW TO ENTER: At various times during the Sweepstakes Period, Sponsor will post a Sweepstakes entry post (“Entry Post”) on the Auto Club Speedway Facebook platform. Entrant must perform the specific action instructed by the respective Entry Post, to be entered into the Sweepstakes. Entries generated by script, macro, or other automated or mechanical means or by any means which subvert the entry process are void. Limit one (1) entry per person, on each platform.
